1 NOTICE INVITING BID (NIB)

NOTICE INVITING BID NO: NHPL / CONTRACTS/ CIVIL/PKG- I/ 2012 DATED January 23, 2012 ("NIB")

- 1.1 NJC Hydro Power Limited (NHPL) is a SPV and a wholly owned subsidiary company of "Bhilwara Energy Limited (BEL)" a company of LNJ Bhilwara Group.
- 1.2 NHPL by virtue of an Memorandum of Agreement signed between State Government of Arunachal Pradesh and BEL has been allotted a 780 MW Nyamjang Chhu Hydro Electric Project on Nyamjang Chhu River in District Tawang of Arunachal Pradesh on BOOT Basis.
- 1.3 Sealed item rate bids are invited on behalf of NJC Hydro Power Limited ("NHPL") for the work of "Civil Works – Upstream Works of Barrage, Gated Spillway with Apron & Abutments, Sluiceway, Head Regulator, Shingle Excluder Ducts, Feeder Channels, Desanding Basins and Collector Pool, Tunnel Intake, Silt Flushing Arrangement, River Diversion Works, Vibro-Compaction for ground improvement, Concrete-Diaphragm cut off Wall, Jet Grouting, Hydro-mechanical Works and other Associated Works", better defined as Works in "Section B : Information and Instructions for Bidders".
- 1.4 This NIB is accompanied by Information and Instructions for Bidders, Bid Forms and Schedules, General Conditions of Contract, Special Conditions of Contract, Technical Specifications and Drawings and all such documents together constitute the Bid Documents.

2 FOR SPECIAL ATTENTION

- 2.1 Bid Documents may be obtained from the address of communication given below from February 07th, 2012 to March 26th, 2012, on any working day between 1000 hrs to 1700 hrs on payment of non-refundable document fee of INR 25,000/- (Indian Rupees Twenty Five thousand only) in the form of Demand Draft drawn in the favour of "NJC Hydro Power Limited." payable at New Delhi, India. In case Bidders choose to obtain the Bid Document by post, an additional non-refundable fee of INR 1,500/- (Indian Rupees One Thousand Five Hundred only) shall be payable towards the Postage Charges.
- 2.2 International Bidder may choose to remit the non refundable fee by Demand Draft in favour of NJC Hydro Power Limited, payable at New Delhi. In such case, amount to be remitted is USD 500 (Five Hundred US Dollars) towards the Bid Document Fee and USD 30 (Thirty US Dollars) towards Postal Charges.

2.3 All Bidders are cautioned that Bids containing any variations or deviations whatsoever from the terms and conditions, specifications, drawings, designs, etc. as contained in the Bid Documents are liable to be summarily rejected as non-responsive unless said variations or deviations are specifically indicated under the terms hereof.

2.4 Bidders are required to sign and submit all the documents, information and schedules stipulated in the Bid Documents including details of construction plant, equipment, manpower & machinery to be deployed for the Works. Incomplete Bids are liable to be summarily rejected.

All Bidders shall be registered under Arunachal Pradesh General Sales Tax Act, Service Tax Rules, Prevailing Labour Laws in the country and Arunachal Pradesh and such other registrations under prevailing laws required to undertake the construction work.

3 SUBMISSION OF BIDS

3.1 Original sealed Bids along with 2 (two) copies superscribed "Bid for the work of Construction of "Civil Works – Upstream Works of Barrage, Gated Spillway with Apron & Abutments, Sluiceway, Head Regulator, Shingle Excluder Ducts, Feeder Channels, Desanding Basins and Collector Pool, Tunnel Intake, Silt Flushing Arrangement, River Diversion Works, Vibro-Compaction for ground improvement, Concrete-Diaphragm cut off Wall, Jet Grouting, Hydro-mechanical Works and other Associated Works" (Package-I) of the Nyamjang Chhu Hydro electric Project " shall be submitted up to 1400 hrs on April 23rd, 2012, at the address of communication given below. Bids received after the stipulated date and time on account of any reason whatsoever shall not be entertained.

3.2 A pre-bid meeting may be held at the discretion of NHPL, the likely date of which may be March, 19, 2012 at 1000 hrs, or as may be confirmed later by NHPL. Communication for Pre Bid Meeting shall be given by Fax, email or Phone not less than three days in advance. Bidder may choose to attend the Pre Bid Meeting at their own cost. Alternatively Bidders may send in their queries to NHPL at the address given here under in case they seek any clarifications. In such case, all clarifications shall reach NHPL not later than March, 19th, 2012 or such date as notified by NHPL for Pre Bid Meeting. Pre Bid meeting shall be held at Noida Office of NHPL.

3.3 Earnest money deposit of Indian Rs. 20,000,000/- (Indian Rupees Twenty Million only) (hereinafter the "Earnest Money Deposit") must accompany each Bid and the Bids not accompanied with the Earnest Money Deposit shall be summarily rejected as non-responsive. The Earnest Money Deposit shall be refunded to unsuccessful Bidders.

3.4 The most recent Income Tax and Sales Tax clearance certificates or the latest assessment orders passed by such departments pertaining to the Bidder shall accompany the Bids.

3.5 Conditional Bids and Telegraphic Bids shall not be entertained.

- 3.6 The Bids shall be opened at the Noida office of NHPL, on April, 23rd, 2012 at 1600 hrs or such other date as notified by NHPL at the office address of NHPL mentioned hereunder. The Bids shall be opened in the presence of the Bidders' representative, who choose to attend, at their own cost and expenses.

4 SCHEDULE OF BID PROCESS

In order to complete the Bidding Process, following Schedule shall be observed:

- Start of sale of Bid Document - 07/02/2012 (1000-1700 Hrs)
- End of sale of Bid Document - 26/03/2012 (1000-1700 Hrs)
- Pre bid meeting - 19/03/2012 (1000 Hrs onwards)
- Submission of bid - 23/04/2012 (Upto1400 Hrs)

5 BID VALIDITY PERIOD

The Bids shall be valid for a period not less than 180 days commencing from the date of opening of Bids ("Bid Validity Period").

6 DISCRETION

NHPL shall have the discretion to reject all or any of the Bids and shall not be bound to accept the lowest or any other Bids or to give any reason for such decisions.

7 RIGHT TO AMEND OR CANCEL THE BID

NHPL reserves the right to amend or cancel the Bids without assigning any notice or reason.
