



120 MW LIKHU IV HYDRO-ELECTRIC PROJECT, NEPAL
INTERNATIONAL COMPETITIVE BIDDING
INVITATION FOR BID – FOR ELECTRO-MECHANICAL WORKS

Green Ventures (Pvt.) Ltd. Nepal (GVN), a Joint Venture company of Bhilwara Energy Limited (BEL), India and Triveni Energy (Pvt) Ltd, Nepal, is setting up 120 MW Likhu IV Hydro-electric Project in Okhaldunga & Ramechhap districts, Nepal, located about 220 Km from Kathmandu, on Build, Own, Operate and Transfer (BOOT) basis. GVN invites sealed bids from eligible local and International contractors for the Electrical & Mechanical works for the project, under Turbine – Generator package (No. LIKHU/GVN/Pkg-03/2012)

The brief scope of work under this package comprises the Design, Manufacturing, Transport, Erection, Testing and Commissioning of 3 nos Turbine & Generator (TG) sets (each of 40 MW) comprising Francis Turbine, Governor, Main Inlet valve, Synchronous Generator, Static Excitation and associated Auxiliaries, Unit Control –SCADA- Automation and Communication System, etc for the Project.
